

RULES OF CONDUCT FOR PATRONS OF THE AMERICAN LEGION FRIERSON-NICHOLS POST 8 TDY SOCIAL QUARTERS

Members of the American Legion, Auxiliary, SAL, and ALR in good standing will be entitled to enjoy all privileges of the TDY Social Quarters and facilities thereof as long as they observe the House Rules and refrain from loud, boisterous, profane, or indecent conduct.

Check cashing policy: **ONLY MEMBERS OF THE AMERICAN LEGION POST 8 (LEGIONNAIRES, AUXILIARY, SAL, AND ALR) WILL BE ALLOWED TO CASH A CHECK IN THE TDY SOCIAL QUARTERS. THERE IS A LIMIT OF \$100.00 PER DAY EXCEPT FOR POST CHECKS.** In the event that the check is returned because of "NSF" (Non-Sufficient Funds), the person will be notified to make good on the amount of the check, plus any current standard bank charges that may apply to cover administrative costs. In addition, the person will not be allowed to cash any further checks without prior approval of the TDY Committee or Executive Board.

NO TWO-PARTY CHECKS WILL BE CASHED

Without prior approval of the TDY Social Quarters Manager, an authorized member will be limited to four (4) non-member guests per day subject to Florida Beverage Department of Regulations.

Guests will be admitted only with an authorized member and must leave when the member leaves. The authorized member is responsible for the conduct of his or her guests at all times.

The game room is provided for the enjoyment of members. Members with guests are requested to be considerate of this when other members desire to play pool. **Members of the American Legion have priority over use of the game room.**

Key Cards: Only those authorized members of American Legion Post 8 (Legionnaires, SAL, Auxiliary, ALR) are to be issued key cards, and **CURRENT YEARS DUES MUST BE PAID.** Expired members will be denied access to the Social Quarters and cannot be signed in as a guest by any member of the entities listed above.

Complaints, criticism, or information concerning the operation of the TDY Social Quarters will be discussed with the TDY Social Quarters Manager and the TDY Social Quarters Chairman and NOT with an employee of the TDY Social Quarters. Members and guests are expected to refrain from making any comments or suggestions at the bar that are found to be offensive and personal in nature concerning Social Quarters employees or their quality of service. Any complaint, criticism, or information must be submitted in writing to the TDY SOCIAL QUARTERS MANAGER and/or the TDY Social Quarters Chairman.

With the exception of service animals, pets are not allowed in the TDY Social Quarters at any time.

ALL beverages, regardless of the container, cannot be brought into or carried out of the TDY Social Quarters or Post 8 building. This rule does not apply to the deck or the beach area of Post 8. No glass containers are allowed on the beach area. UNOPENED sodas and water are permitted to be taken out.

No minors under 21 years of age are allowed in the TDY Social Quarters bar area after 8:00 p.m. and at no time are they allowed to sit at the bar, except for current members of the Armed Services. The alcove is not considered a part of the TDY Social Quarters bar area. **Regardless of this exception, no one under the age of 21 can be served an alcoholic beverage at any time.**

The TDY Social Quarters Manager or Bartender on duty is responsible to see that these rules of conduct are strictly complied with.

All patrons are required to show their current American Legion membership card upon request to the TDY Social Quarters Manager or Bartender on duty. PLASTIC PUFL CARDS are acceptable if a picture ID is produced to confirm their identity.

Any member who violates any of these rules or allows their guest(s) to do so will be subject to disciplinary action by the TDY Social Quarters Committee and/or the American Legion Post 8 Executive Board.

American Legion, Auxiliary, SAL and ALR members from American Legion Posts other than Post 8 and visiting legion members for countries other than the United States are guests the Post 8 TDY Social Quarters and shall conform to all rules.

ARTICLE VII, SECTION 5, Paragraph 3 of the Constitution and By Laws of American Legion Post 8 states: "The Social Quarters Committee shall adopt rules governing the operation of the Social Quarters and conduct of the members therein, said rules being subject to the approval of the Post Executive Board and posted by the Social Quarters Committee in a conspicuous place accessible to each and every member of the Post and shall have the authority to suspend the Social Quarters privileges of any person violating said rules of conduct. Suspension could be for any period up to and including forever, provided that any Post member so suspended shall have the right of appeal in writing to the Post Executive Board. The decision to current paid-up Post 8 members. There is no limitation regarding the length of suspensions for non-member guest of Post 8, nor does a non-member have the right to appeal a suspension to the Post 8 Executive Board.

Dress Code: Appropriate attire is required in the Main Hall, the Lakeside Room, and the TDY Social Quarters of Post 8. Muscle Shirts and Cut-Offs are not allowed. Sleeveless shirts are acceptable except Wednesday and Friday Night Dances or during special events in the Main Hall.
